- 2. Adoption or Modification of the Agenda
 - Commissioner Crawford motioned to adopt the agenda and Commissioner McCandless seconded

 - Commissioner McCandless motioned to retain current officers and Commissioner Crawford seconded
- 4. Adoption of Minutes from the Previous Meeting for April 23, 2018
 - Commissioner Crawford motioned to adopt the minutes, Commissioner McCandless seconded.
 Commissioner McCandless requested an item to be added to the Spring agenda regarding nuclear power in Illinois and Exelon's future plans. An Exelon official will be invited to provide an update at this future meeting

- Host State/Chairman
 - Chairman Klinger will be attending the upcoming LLW Forum Meeting in Washington State, and a Site B reactor tour. He will provide an overview at the next meeting
 - Chairman Klinger attended the CRCPD 50th Anniversary Meeting in Charleston, SC, May 21-24,
 2018. Many excellent presentations
 - Waste Control Specialists (WCS) has been purchased and is now solvent. This is where many
 generators send their waste. The Nuclear Regulatory Commission (NRC) is reviewing their
 application for a Spent Fuel Interim Storage Facility
 - Chairman Klinger retired from the Illinois Emergency Management Agency (IEMA) December
 31, 2017. With his retirement, Adnan Khayyat, now serves as the Division Chief of Nuclear
 Safety. Kelly Horn serves as Section Head over LLRW Decommissioning, among other programs
- Kentucky Report
 - Matt McKinley (KY) provided an update on the TENORM litigation. KY continues to collect pursue settlements and some of the entities involved have filed bankruptcy.
 State officials have decided the best remediation is to leave in place and monitor.
 - Maxey Flatts and Paducah are seeing little activity relevant to CMCC
- Executive Assistant Report
 - Lori Beagles provided an update on the fiscal year 2018 expenditures and fund balance.
 The CMCC was within their budget for the year, showing an increase in fund balance of \$10,321
